### Non-executive Directors

#### Siegfried Luther

*Chairman of the Board*

Born in 1944, Siegfried Luther studied law and business management in Münster, Germany. In 1974, he joined Bertelsmann AG as director of the Tax department. Seven years later, he was appointed Deputy Head of the Accounting and Tax Department. From 1985 on, he headed the Corporate Treasury Department. In July 1990, the Supervisory Board appointed Siegfried Luther to the Bertelsmann AG Executive Board. He also took over the responsibilities of Chief Financial Officer and Head of the Bertelsmann AG Corporate Centre. In August 2002, he was appointed Deputy Chairman of the Bertelsmann AG Executive Board. A member of the Board of Directors of RTL Group since July 2000 he was appointed Chairman of the Board in December 2004. Siegfried Luther retired from the Bertelsmann AG Executive Board when his contract expired on 31 December 2005.

#### Martin Taylor\*

*Vice Chairman of the Board*

*Chairman of the Nomination and Compensation Committee of RTL Group*

*Chairman of Syngenta*

Martin Taylor (born in 1952) began his career as a financial journalist with Reuters and the Financial Times. He then joined Courtaulds plc, becoming a director in 1987, and then Chief Executive of Courtaulds Textiles plc on its demerger in 1990. He moved to Barclays plc in 1993 as Chief Executive, a post he held until the end of 1998. From 1999-2003 he was Chairman of WH Smith PLC and from 1999 to 2005 International Advisor to Goldman Sachs. Currently he is Chairman of the Board of Syngenta AG. He has done various pieces of work for the British Government and served for five years as a member of its Council for Science and Technology. Appointed as independent non executive director in July 2000 (at the moment of the creation of RTL Group), he took over the responsibilities of Vice Chairman of the Board in December 2004.

## Günther Grüger

*Executive Vice President Corporate Controlling and Strategy of Bertelsmann AG*

Günther Grüger, born in Germany in 1951, is currently Executive Vice President Corporate Controlling and Strategy of Bertelsmann. From 1983 until 1997 he held various positions at Bertelsmann. Before joining Bertelsmann he worked in the Corporate Controlling Department of Oetker Group. He holds a diploma and a doctorate in Economics from the University of Münster, Germany. Günther Grüger is married and has two children.

## Hartmut Ostrowski\*\*

*Designated Chairman of the Executive Board and Chief Executive Officer, Bertelsmann AG*

After having studied Business Administration at the University of Bielefeld, Hartmut Ostrowski (born 1958) joined Bertelsmann in 1982 as Executive Assistant in what was then Bertelsmann Distribution. A year later, he was head of the credit management division. In 1988, he became Managing Director of a German subsidiary of Security Pacific, at the time the fourth-largest bank in the United States. In April 1990, he returned to Bertelsmann Distribution as head of a business unit. In July 1992, he was appointed Managing Director, and in July 1995, he became CEO of the newly formed Bertelsmann Services Group. Hartmut Ostrowski was appointed to the Arvato Executive Board in 1996 and on 1 September 2002, he became CEO of Arvato AG and also member of the Bertelsmann AG Executive Board. Since 1 January 2008, Hartmut Ostrowski is Chairman & CEO of Bertelsmann AG.

## Thomas Rabe

Chief Financial Officer and Head of the Corporate Centre of Bertelsmann AG*

Thomas Rabe, born in Luxembourg-Ville in 1965, holds a Diploma and a Doctorate in Economics from the University of Cologne. He started his career in 1989 at the European Commission in Brussels. From 1990 to 1996 he held various senior positions at Forrester Norall & Sutton (now White & Case) in Brussels as well as the state privatisation agency Treuhandanstalt and a venture capital fund in Berlin. In 1996, he joined Cedel International (Clearstream, following the merger with Deutsche Börse Clearing) where he was appointed Chief Financial Officer and member of the Management Board in 1998. In 2000, Thomas Rabe became Chief Financial Officer and member of the Executive Committee of RTL Group. In March 2003 he was also appointed Head of Corporate Center and responsible for the Luxembourgish activities of RTL Group. Thomas Rabe is Chief Financial Officer and Head of the Corporate Centre of Bertelsmann AG since January 2006.

## Onno Ruding\*

Born in 1939, Onno Ruding served as the Minister of Finance of The Netherlands, for the Christian Democratic Party (CDA) from November 1982 until November 1989. He first became a Director of Citicorp in July 1990 and was, effective March 1, 1992, appointed Vice Chairman of Citicorp in July 1990 and was, effective March 1, 1992, appointed Vice Chairman of Citicorp/Citibank in New York. He retired on September 30, 2003. In January 2002, he became Chairman of the Board of the Centre for European Policy Studies (CEPS) in Brussels, the largest independent think-tank in Europe addressing subjects related to European Integration.

## Jacques Santer\*

Before Jacques Santer (born in 1937) became Chairman of the Board of CLT-UFA in May 2004, his distinguished career covered a variety of political roles including Member of the European Parliament (1974-1979 and 1999-2004), Prime Minister of Luxembourg (1984-1995) and President of the European Commission (1995-1999).

Gerhard Zeiler, born in 1955 in Vienna (Austria), joined RTL Group in November 1998 when he was appointed Chief Executive Officer (CEO) of RTL Television in Cologne. In this capacity, Zeiler was responsible for the German RTL family of channels (RTL Television, Vox, RTL II, Super RTL, N-TV). In March 2003 Gerhard Zeiler was additionally appointed CEO of RTL Group. He handed over the management of RTL Television to Anke Schäferkordt in September 2005 to fully concentrate on RTL Group's international channel architecture. In his function as CEO of RTL Group, Gerhard Zeiler is a member of the Supervisory Boards of M6 in France and RTL Television in Germany and Chairman of the Board of M-RTL in Hungary. He is also a member of the Bertelsmann AG Executive Board since October 2005. Gerhard Zeiler began his career as a freelance journalist and then became press spokesman for the Austrian Minister for Education and the Arts, Dr. Fred Sinowatz, whom he eventually followed to the Federal Chancellor Office in 1983. Later he continued working in the same capacity for Federal Chancellor Dr. Franz Vranitzky. In 1986 he became Secretary-General of the Austrian public broadcaster "ORF" in Vienna. After a two-year period as CEO of Tele 5 and a further two-year period as CEO of RTL II, he was elected Chief Executive Officer of ORF in 1994 and stayed in this position until November 1998.

Elmar Heggen, born in 1968, holds a diploma in Business Administration from the European Business School and graduated as Master of Business Administration (MBA) in Finance. In 1992, he started his career at the Felix Schoeller Group, becoming Vice President & General Manager of Felix Schoeller Digital Imaging in the UK in 1999. Dawn Airey (47) began her broadcasting career as a management trainee for Central TV in 1985. In 1989 she became Director of Programme Planning at Central and was appointed to the Central broadcasting board. In 1993 she moved to the ITV Network Centre as Controller of Children's and Daytime Programmes and in 1994 moved to Channel 4 to become Controller of Arts and Entertainment. In 1996 she was appointed Director of Programmes for Channel Five and was promoted to Chief Executive in 2000. In 2003 she was appointed Managing Director Sky Networks and was responsible for all of Sky's wholly owned channels (excluding sport). In 2006 she was made Managing Director Channels and Services with responsibility for all third party channels, joint ventures and networked media. In 2007 she joined ITV as Director of Global Content and in 2008 she became member of the Board of ITV.

### **Christopher Baldelli**

*Chairman, RTL Radio France*

Christopher Baldelli, born in 1965, was appointed Chairman of RTL Radio France's Executive Board as of 1 August 2009. He joined RTL Group's subsidiary Groupe M6 in June 2006 as its Secretary General of Programming. Since November 2006 he had been CEO of M6 Thématique, directing the company's thematic TV channels such as W9, Téva and Paris Première. Under his leadership, the free digital channel W9 has consistently grown its audience to become the most-watched new DTT channel among young viewers. W9 first achieved a positive operating profit on an annual basis in fiscal year 2008.

Prior to joining Groupe M6, Baldelli worked in various executive positions for the public TV channel France 2 (1999 to 2005), including as its Directeur Général from June 2002 to August 2005, and for the media division of the Lagardère group (1997 to 1999).

After graduating from École Normale Supérieure at Saint-Cloud, Baldelli graduated from IEP Paris (Institut d'Études Politiques de Paris). From 1991 to 1997, he held various positions as a high civil servant, specialised in media regulation.

## Alain Berwick

Alain Berwick, born in Luxembourg in 1957, started his career at Leesch Frères S.A. in 1983, becoming Chief Commercial Officer of Botex S.A., a Leesch Frères company, in 1984. From 1985 until 1986 he has been Head of Sales at ELCO Luxembourg. In 1986 he joined IP Luxembourg, where he was appointed Managing Director in 1993. Since 1994 he is Chief Executive Officer of RTL Radio and Télé Lëtzebuerg. He is also Member of the Board of Directors of CLT-UFA, BCE and President of the Management Committee of IP.

Tony Cohen, born in 1953, began his career as a journalist working on London regional newspapers and the Sunday Times. He joined London Weekend Television in 1979 where he held senior production posts. In 1995 he was appointed managing director of the Broadcasting Division of Pearson Television. He later became co-chairman of the North American division of Pearson Television, and president of its production operation in Los Angeles. In 2000 he returned to the UK to run worldwide production and in 2001 became CEO of RTL Group's production arm, FremantleMedia (formerly known as Pearson Television), based in London.

## Philippe Delusinne

Philippe Delusinne, born in 1957, started his career in 1982 in the advertising business after an academic background in Law and Marketing. He held different positions in the Account Department of Ted Bates, Publicis and FCB. In 1988 he was appointed Deputy Managing Director at McCann Erickson and in 1993 became Chief Executive Officer of Young & Rubicam. After an experience of 20 years in managing local and international clients in the advertising business and participating in the media business revolution, Philippe Delusinne was appointed Chief Executive Officer of TVI in Belgium in March 2002.

Vincent de Dorlodot, born in 1965, was appointed general counsel of RTL Group in April 2000. Anke Schäferkordt, born in 1962, has been CEO of RTL since September 2005. After studying business administration Anke Schäferkordt began her professional career at Bertelsmann AG in 1988. In 1991 she went to Cologne to become an executive assistant for sales controlling and strategic planning at RTL plus and one year later took over the Controlling Department. From 1993 to 1995 Anke Schäferkordt was a Director in charge of the Corporate Planning and Controlling Division at RTL. In 1995 Anke Schäferkordt moved to VOX television where she was in charge of business affairs and in 1997 she was also named Program Director. Anke Schäferkordt has been the CEO of VOX since 1999. In February 2005 she was appointed Chief Operating Officer and Deputy CEO of RTL. In these offices she was responsible for Finance, Technical, Information and Media Policy as well as the General Secretary, the IP Sales Organization and the broadcaster VOX. From 1981 to 1986, de Tavernost headed various governmental delegations, and eventually worked as director of the audiovisual activities at Lyonnaise des Eaux. In 1987 he joined M6 as managing director and became president of M6 Publicité in 1988. Since May 2000 de Tavernost has held the post of CEO and chairman of the Management Board of the M6 Group. He is also President of the Association of Commercial Televisions since June 2003.

From 1986 to 1988 he served as a Programme Director for Radio Charivari Nuremberg and was involved in starting other Charivari stations in various Bavarian cities. From 1989 to 1992 Gert worked as a consultant and producer for the BCI Group, a European consulting company for radio/TV stations and a music production house with investments in various other media companies. In 1993 Gert became a co-owner of the BCI Group and the CEO of the company and served in that role till 2003.

He also served as Managing Director of the news channel N-TV, as Managing Director RTL New Media, Head of the Internet & New Technologies division at RTL Group in Luxembourg, and as Head of Business Development for TV in the German-speaking territories, CLT-UFA. Züll also sat on the supervisory boards of Super RTL and IP Deutschland. Prior to his career at RTL Group, Züll worked for the Boston Consulting Group in Germany and Thailand from 1993 to 1999. Johannes Züll studied Business and Economics at the University of St. Gallen (HSG) in Switzerland and at Indiana University in the US. He holds an MBA from the University of St. Gallen.
